IT IS AGREED

1. That the period of the Agreement of Apprenticeship shall be **FIVE** years.....months from the **10th** day of **JULY** 19**78**.....

2. That the signatories undertake to observe and fulfil the several conditions and obligations set out in the Agreement.

3. That if the period of the Agreement of Apprenticeship mentioned in Clause 1 is less than the normal period of apprenticeship prescribed by the 'Notes on Completion' printed on the first page of this form, any shorter period takes account of:

(a) Continuance by the Apprentice in full-time education or approved training appropriate to the occupation until **10th July** 19**83**

or
(b) The period from 19..... to 19..... spent in the service of another Employer which has contributed to the appropriate training of the Apprentice.

CONDITIONS OF AGREEMENT OF APPRENTICESHIP

A. THE EMPLOYER AGREES:

1. To teach the Apprentice the skilled occupation specified above to a standard approved by the National Joint Council for the Motor Vehicle Retail and Repair Industry by affording the Apprentice such opportunities of learning it as may be obtained by employment in appropriate parts of the Employer's premises, by attendance at courses of practical and theoretical instruction held elsewhere or by temporary employment in the premises of another Employer.

2. For a total of at least three years during the period of the Agreement of Apprenticeship to afford the Apprentice facilities for attendance at a College of Further Education or similar establishment for the purpose of receiving further education appropriate to his occupation, the conditions of such attendance being:

(a) Where suitable instruction is available during working hours the Employer shall make provision for the Apprentice's attendance.

(b) Where suitable instruction is available only partly during working hours and partly in the evenings the
